Planning and your Local Ombudsman

The Parish Council has recently had to consider a situation which could well provide a lesson for the future for many of us in the village. The actual details do not matter in this particular case but the problem brought together two matters about which we hear a great deal and which directly affect us. One is the Town Planning Laws and the other the Local Ombudsman.

In this case planning permission was granted for the erection of some houses in "outline". In other words no details were shown. In most cases this probably would not have mattered, but unfortunately the development was behind existing properties and once building started it became painfully obvious to a few of these householders that everything was not as supposed by them. The new houses were correct in position, but in one specific instance very much above in elevation, and quite unacceptable.

Representations were immediately made to the Borough Council, local MP, and local Ombudsman.

The Council and MP were not able to intervene and therefore the Ombudsman was the last hope.

On the face of it the problem these hosueholders had was exactly one that the office of Ombudsman was created to solve.

In this case he could not and the lesson to be learned from this decision is of very great importance. Once planning permission has been granted in whatever form -"outline" or "detail" - that is the end of the matter. Only the local authority buying back the permission, by means of a compensation to the applicant, can prevent the building work being carried In these times of general money shortage that solution has no hope.

So if you are worried about the effect of a planning application adjoining your property go along to the Dower House and ask to see all the plans submitted. have a right to do this. you are not 100% satisfied that your interests are being safeguarded then talk to the Chairman of the Parish Council who will put you in touch with a Parish Councillor who can advise you. As these particular parishioners have now found to their cost, the opportunity to object has been lost forever.

community centre

One amenity of our Village that is much talked about at the present time is the building of the Community Centre on the Recreation Ground. Does it have to be a new building? This newsletter asks this question because another Parish of roughly the same size as ours has bought an existing building. Again, does it have to be financed by direct subscriptions? £80,000 was raised to purchase and equip this centre. The rates were increased for three years and the owners, the District Council, were very co-operative and allowed deferred payments without interest. This avoided the problem of borrowing money at high interest rates.

Some rooms were retained by the Parish Council for letting to community organisations for occasional meetings and to provide an Information Room to house footpath maps and other items of Parish interest. The remainder of the accommodation has been let to community organisations for this sole use.

Have we a suitable building? Downingbury Farm buildings are largely empty and unused, but if cottage industries are located there as suggested in Pembury 2000 why should it not become the focus of the new Village. Or alternatively, what about building over the Camden car park - an ugly 'hole' in our Village Green by any standards. Perhaps a combined development with the petrol company who want to demolish the present Camden Garage.

However, this is all thinking aloud - what is needed immediately is your attendance at the special Village meeting in the Village Hall on October 13th at 8.00pm to hear a progress report on the present proposals from the Community Centre Council.
